The Bursary Code of Palacký University, Olomouc, as amended is implemented for the Faculty of Medicine and Dentistry of Palacký University, Olomouc (hereinafter the "Faculty") as follows:

## Article 1 Undergraduate students

1) Full-time students of the Faculty who graduate with honours are entitled to a merit scholarship for outstanding study results calculated as follows:

Cumulative Grade Point Average (CGPA) for the whole time of study	Scholarship per semester
CGPA = 1.00	CZK 800
1.00 < CGPA <1.51	CZK 400

- 2) The total merit scholarship for outstanding study results equals the scholarship per semester multiplied by the number of semesters of the standard length of study in the respective programme of study.
- 3) The merit scholarship is paid as a lump sum after the completion of study by wire transfer to a bank account designated by the student.

## Article 2 Postgraduate students

- Scholarships for full-time doctoral students are awarded for the respective academic year to students who have not exceeded the standard length of study of the accredited study programmes. The length of study includes the length of previous study on doctoral degree programmes.
- 2) The scholarships for full-time doctoral students equal CZK 6,000 in the first year of study, CZK 7,000 in the second year of study and CZK 8,000 in the third and fourth years of study.
- 3) Provided that the financial situation of the Faculty is favourable, the Dean may decide on a one-off increase in the scholarship. Students who have interrupted studies are not entitled to the scholarship as long as their studies are interrupted.
- 4) Scholarships under Paragraph 2 are paid monthly by wire transfer to a bank account designated by the student.
- 5) Students on programmes of study taught in English may qualify for J. L. Fischer Scholarship in accordance with the existing Instruction of the Rector of Palacký University, Olomouc. For the Faculty this scholarship equals EUR 3,000. This scholarship is awarded by the Dean of the Faculty subject to consideration of the request by the Research and Scientific Committee of the Faculty.

#### Article 3

#### Research and teaching activities of students

- 1) Scholarships for research and teaching activities of students are awarded under the Directive of the Dean of the Faculty on research and teaching activities of students upon proposal by the head of the respective department and subject to approval of the Dean of the Faculty, or upon proposal of the Dean of the Faculty.
- 2) The scholarship amount shall not exceed CZK 4,000 for a semester.
- 3) The scholarship for teaching activities is paid as a lump sum after the end of the respective semester.
- 4) The scholarship for research activities is paid after a successful oral presentation of the results of such activities at a Student Research Projects Conference. If more students participate in one research project, the scholarship is divided in proportion to their contributions (as determined by the supervisor).
- 5) At the Student Research Projects Conference three best presentations in individual categories will be chosen by an expert board. The authors of these research projects will be awarded an extraordinary scholarship as determined by the Dean.

#### Article 4

#### **Extraordinary scholarship**

- 1) Both undergraduate and postgraduate students participating in research and teaching activities may be awarded a monthly extraordinary scholarship by the Dean of the Faculty in order to stabilize the staffing situation at the respective department. The monthly scholarship shall not exceed CZK 10,000.
- 2) Both undergraduate and postgraduate students may be awarded an extraordinary scholarship for an original paper published in a journal having an impact factor.
- 3) The scholarship awarded under Paragraph 1 may be paid monthly.

#### **Final Provisions**

- 1) The present Directive comes into force on the date it is issued, i.e. signed by the Dean of the Faculty, and becomes effective upon its publishing on the website of the Faculty.
- 2) Dean's Directive No. LF B3-5/2011-PN of 1 September 2011 is hereby revoked.
